COMMITMENT FORM

Please read and sign below to ensure your complete understanding of Team IMPACT's Marathon Team requirements.

Fundraising Commitment:

I agree to collect a minimum of \$3,500 by December 3, 2019, to support Team IMPACT. I understand that Team IMPACT reserves the right to charge the credit card provided for the balance I owe if I have not met my fundraising commitment by December 3, 2019. *I understand I will be responsible for the race entrance fee and that the entrance fee does not count towards my fundraising total.*

CrowdRise Commitment:

I agree to use CrowdRise, as required by the TCS New York City Marathon, to do my fundraising. I understand that this means I must go to the Team IMPACT's CrowdRise page and create my own individual runner page as a part of Team IMPACT's Marathon Team. I agree to have my individual CrowdRise page set up by May 3, 2019. Team IMPACT will assist with this process. I agree to use the CrowdRise feature allowing me to thank my donors in a timely manner. I understand that CrowdRise will streamline the online donation process, but it will not record offline donations (sent through the mail or given to me personally). I understand all offline donations should be sent to Team IMPACT in the form of a check and received prior to the final fundraising deadline. Once offline donations are received, Team IMPACT will notify me and add those donations to my CrowdRise page.

Cancellation Policy:

I understand that I may cancel my participation with Team IMPACT for the 2019 TCS New York City Marathon, waiving my responsibility for the fundraising minimum stated above, any time on or before August 1, 2019 by contacting Carolyn Murphy at Team IMPACT in writing. I understand that if I cancel my participation in the 2019 TCS New York City Marathon all fees paid, and any donations received by Team IMPACT to that point will not be refunded. I understand that after August 1, 2019, I am solely responsible for raising the entire fundraising minimum, even if for any reason, including injury, I am unable to run in the 2019 TCS New York City Marathon.

Registration:

I agree to pay the registration fee to the New York Road Runners. I understand that this does not count toward my fundraising minimum for Team IMPACT. I understand that Team IMPACT will inform me of the details of the marathon's registration. I will not contact the New York Road Runners directly to secure my number.

Race Rules:

I agree that I will not begin the race prior to the official start time; I will not compete in a manner which, in the judgment of the race officials, interferes with race operations or other participants; I will not reproduce or transfer my official bib number.

Liability:

I will not hold Team IMPACT responsible for injury or death related to training for, or participating in, the 2019 TCS New York City Marathon as part of Team IMPACT's Marathon Team.
